## Terms and Conditions

### FUJITSU COMPUTER PRODUCTS OF AMERICA, INC. EVERYBODY SCANSNAP QUESTIONNAIRE CONTEST OFFICIAL RULES

#### NO PURCHASE NECESSARY TO ENTER OR WIN

To enter and be eligible to win, you must submit a Questionnaire and completed Sweepstakes Entry Form between February 1, 2012 and 11:59 P.M. Pacific Time (“PT”), March 31, 2012. All names, addresses, email addresses, and purchase details entered must be valid or will be void. All entries become the property of Fujitsu Computer Products of America, Inc. Fujitsu is not responsible for lost, late, incoherent, incomplete, or misdirected entries, or any electronic miscommunications or failures, technical hardware or software failure of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmissions which may limit an entrant's ability to participate in the giveaway.

The winners will be selected at the end of the contest from all eligible entries received during the contest period. Participation in this contest constitutes entrant’s full unconditional agreement and acceptance of these Official Rules. Failure to comply with these rules may result in disqualification from the Contest. Fujitsu reserves the right to disqualify permanently from any contest or promotion it sponsors any person it believes has intentionally violated these rules or any entrant it finds to be acting in an unsportsmanlike or disruptive.

(1) **ELIGIBILITY:** The Everybody ScanSnap Questionnaire Contest is open only to legal residents of the United States (excluding U.S. possessions, territories, overseas military installations, Puerto Rico, and residents of Rhode Island). All entrants must have reached the age of eighteen (18) as of the date of the entry to be eligible for this giveaway. Employees, independent contractors, officers, and directors of Fujitsu Computer Products of America, Inc., its affiliates, subsidiaries, advertising promotion and fulfillment agencies, legal advisors, and the immediate family members and persons living in the same household of such persons are not eligible to participate in the Everybody ScanSnap Questionnaire Contest. Winners will be notified by either telephone or e-mail, in Fujitsu's sole discretion, on or after March 31, 2012 at which time a full shipping address and phone number will be required for fulfillment of the prize. Winners will have 15 days from notification to accept the prize by replying to notification e-mail or telephone call. From that point, the winners will receive their prize via mail within 15 days of receipt of confirmation.
